(1) 根據《商業登記條例》第310章的規定,就同步商業登記申請註冊的法團而言,有關公司須在它開始經營業務當日起計的1個月內,以 書面通知稅務局局長其業務資料,包括業務名稱、業務描述及業務性質、營業地址及開業日期。不遵辦上述任何事項,即屬違法,可處 最高5,000元罰款及監禁一年。

Pursuant to Business Registration Ordinance Cap. 310, where the company incorporated and registered under the one-stop company incorporation and business registration regime, it is required to notify the Commissioner of Inland Revenue in writing within one month of the date of commencement of their businesses. The business particulars concerned include business name, description and nature of business, business address and date of commencement of business. Failure to comply with the above requirements may lead to prosecution. The maximum penalty is \$5,000 and imprisonment for one year.
